This means its time to have your RV serviced for a trouble free camping season!

Items to Have Checked:

- **BATTERY CONDITION**
 - Load Test
 - Check Fluid Levels
- **BATTERY CHARGING SYSTEM**
 - 12 Volt
 - 110 Volt
- **FILL PROPANE TANK**
 - Test for any Propane leaks
 - Light all Appliances
- **ALARM CHECKS**
 - Smoke Detector - replace Battery & "Test"
 - CO Detector - "Test"
- **REFRIGERATOR**
 - Check Chimney for blockage from nests of all sorts
 - Check for Soot Buildup
- **FURNACE**
 - Check outside exhaust for nests from "Mud Daubers"
- **DUMP VALVES**
 - Lubricate gates
 - Lubricate cables if so equipped
- **FLUSH OUT WATER LINES**
- **WASH AND WAX MOTOR HOME**

Cooking with LTV

Never Fail Cream Puffs



1 cup water
1 cup flour
1/2 tsp. salt

1/2 cup butter
1 tsp. baking powder
3 eggs

Combine flour, baking powder and salt in a bowl. Set aside.

Heat butter and water until butter is melted. Remove from heat and mix in flour mixture. Stir vigorously until mixture forms a mass, leaving the sides of the saucepan. Cool for 5 minutes.

Add eggs, one at a time, beating after each addition until thoroughly combined. Drop in mounds about the size of an egg, well apart

on a greased cookie sheet. Bake @ 425 for 15 minutes, then lower heat to 375 and bake until puffs are lightly browned, about 25 minutes. Turn off the heat and leave the oven door open to allow puffs to dry a few minutes. Make a slit on the side and fill with whipped cream or dessert filling.

Yield: 1 dozen, average size.
